Next they talked about the restrooms at the concession stands and they decided after they were done with Commissioner Discussion they would go out and look at the project to get a better idea of the project. Before Chris left he mentioned he hired Clay Parkin back as a full time deputy and he will submit a payroll change to the Clerk.

During Commissioner Discussion the Clerk informed them that the Media Center would be here to take pictures of them and the other employees who want their picture on the new County website on the September 8th Scott said he would get his and Chris Tedder also agreed too prior to the meeting. By consensus they agreed to have their picture taken for the County website.

Ron adjourned the meeting at 10:50 and stated they would continue at 11:00 at the concession stands at the fairgrounds. After looking at the sewer pipes and the stalls they asked Matt to get bids out for raising the stools to help with the grade of draining.
