John Unruh, Bert Lowery, Ron Freeman, Kristi Cooper, Jay Schmidt, Scott James, Chay Howard, Franklin Ruff and Tony Factor attended the meeting.

Consent agenda included: Agenda and 11-30 minutes
John opened the meeting after the prayer by Tony.
Ron moved to approve the consent agenda and Bert seconded, motion carried 3-0.

Jay Schmidt came and presented a payroll change for M Allsbury (merit increase). After review Bert moved to approve the payroll change and Ron seconded, motion carried 3-0.
