After some discussion John asked Matt to look into references on Miller since there bid came in \$600 lower and with 1 additional application of chemical and report back Monday. Another item he presented was a summary of the G.O Bonds and reported at of today's accounts payable that the County is completely out of debt except for the G.O Bond with the hospital. Next he announces the deadline regarding the USDA access funds of \$510,959.42 in the Long Term Recovery funds have been released and \$1604.13 from Disaster Donations Relief fund. Matt suggested moving the total funds of \$512,563.55 to the building fund in County General per the auditor's suggestion. After a little more discussion John moved to transfer \$512,563.55 to the building fund and Bert seconded, motion carried 3-0. Also he presented a quote from Sagebrush on the lighting controller at the Commons building and explained they need to replace it and Bert moved to approve the quote from Sagebrush for \$3209.95 and Ron seconded, motion carried 3-0. Additionally he touched on the subject on pricing a new server for the Courthouse and District Court and reminded them they current server is 7 years old and he would report back once he has figures. Last he reported that he got with Craig regarding the lighting on the front steps and he presented several ideas which include, removing lights, build cage around lights, laser, ultrasonic wave machine and gel for deter the birds from landing. After some discussion they agreed to look at making the lighting flush with the ceiling and they would talk more on Monday.
