She did report that the U.S Postal Service came Wednesday (May 27) and made the statement they would be bringing a permanent post office back to Greensburg and within 30 days they would commit to a building. She also added she has spoken with the mayor of Mullinville regarding a grant that would help them with the waterline project they would like to start in the near future. And last she touched on the topic of the ROZ program and explained the importance of it and
