## Kiowa County Commissioners Meeting Courthouse Lower Level Conference Room May 31, 2012

9:00: After a prayer, Don opened the meeting.

Ron moved and John seconded to approve the consent agenda with a spelling correction in the minutes of May 21, motion carried.

John moved and Ron seconded to approve tax correction, motion carried.

Gunnar Stauth, Road & Bridge Supervisor, came with the following:

He reported that an adjuster from EMC came to inspect the loader that needs repairs at N. Landfill. He also reported on road up keep by oil companies, repairs on equipment and addressed his budget for 2013.

10:45: Dee Chandler, Executive Director of Economic Development and Rick Sherer, Eco. Dev. Board President, came to present their request of \$20,000 for 2013 to the Commission. Dee updated them on possible tenants in the business park; there are two new businesses opening in town.

10:55: Candace Lattin, County Attorney, came to present her 2013 budget request.

11:15: Eric Peters came back to discuss the Community Service Officer position. He suggested he could possibly be that person instead of hiring another person. After discussion, the Commission asked the Clerk to contact Ann Dixson with that suggestion.

11:45: Jim Crawley, Exe. Dir. of the Kiowa County Museum, and Travis Barnes, Historical Society Board President, came to present their budget request for 2013.

Ray Stegman came in to discuss the top floor carpet issues. After discussion it was decided Ray will contact that company to decide what can be done.
