# RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF KIOWA COUNTY, KANSAS, REARRANGING COMMISSIONER DISTRICTS PURSUANT TO K.S.A. 19-204 et. seq.

WHEREAS, K.S.A. 19-204 et. seq. requires the board, on the day of the organization of the board or as soon thereafter as may be possible, to rearrange commissioner's districts to ensure they are as compact and equal in population as possible.

WHEREAS, the Board of County Commissioners on January 17, 2012, received information and heard recommendations from the Kiowa County Appraiser and Kiowa County Clerk.

WHEREAS the Board of County Commissioners, on January 17, 2012 having reviewed the map created using the latest census information and having found the proposed rearranged commissioner district lines in compliance with all statutory requirements and restrictions, approved the use of the map for the rearrangement of the commissioner districts.

BE IT HEREBY RESOLVED the Kiowa County Commissioner Districts are hereby rearranged as follows:

#### **COMMISSIONER DISTRICT #1 boundaries are as follows:**

Beginning at the NE Corner of Kiowa County (Section 1 Township 27 Range 16) following the section line South (61 Ave) 24 miles to the (SE corner of Section 36 Range 16 Township 30) then west on the section line (Street Y) 10 miles to the (SW corner of Section 33 Township 30 Range 17) then North on the section line (41 Ave) 9 miles to the (NW corner of Section 21 township 29 Range 17) then East on section line 1 mile (PSt) (NE corner of Section 21 Township 29 Range 17) then North on the section line (43<sup>rd</sup> Ave) 5 miles to the (NW corner Section 27 Township 28 Range 17) then East 2 miles on the section line (KSt) to the (NE corner of Section 26 Township 28 Range 17) then North 9 miles on the section line (47<sup>th</sup> Ave) to the (NW corner of Section 12 Township 27 Range 17) then East 1 mile on the section line (BSt) to the (NE corner of Section 12 Township 27 Range 17) then North 1 mile on section line (49<sup>th</sup> Ave) to the (NE corner of Section 1 Township 27 Range 17) Kiowa county line then East 6 miles on the section line to the NE corner of Kiowa County to POB.

#### **COMMISSIONER DISTRICT #2 boundaries are as follows:**

The POB being 10 miles East of the SE corner of Kiowa County (SW corner of Section 33 Township 30 Range 17) then North on the section line (41<sup>ST</sup> Ave) 9 miles to the (NW corner of Section 21 Township 29 Range 17) then East 1 mile on section line (P St) (NE corner of Section 21 Township 29 Range 17) then North on the section line (43<sup>rd</sup> Ave) 5 miles to the (NW corner Section 27 Township 28 Range 17) then East 2 miles on the section line (K St) to the (NE corner of Section 26 Township 28 Range 17) then North 9 miles on the section line (47<sup>th</sup> Ave) to the (NW corner of Section 12 Township 27 Range 17) then East 1 mile on the section line (B St) to the (NE corner of Section 12 Township 27 Range 17) then North 1 mile on section line (49<sup>th</sup> Ave) to the (NE corner of

Section 1 Township 27 Range 17) Kiowa County line then West 9 ½ miles on the section line to the ½ mile line of (Section 4 Township 27 Range 18) then South on the ½ mile line thru (Sections 4,9,16,21,28,33 Township 27 Range 18) and (Sections 4,9 Township 28 Range 18) (30<sup>th</sup> Ave) to the city limits of Greensburg Then West on I Street to Bay Street then South on Bay Street to Scott Street then West on Scott Street to (29<sup>th</sup> Ave) Then South on 29<sup>th</sup> Ave 1 ½ Mile to the (SE Corner of Sec 29 Township 28 Range 18) then West 1 mile to the (SW Corner of Section 29 Township 28 Range 18) (183 Hwy) then South 13 miles to the (SW Corner of Section 32 Township 30 Range 18) Kiowa County line then East 7 miles to the POB.

### **COMMISSIONER DISTRICT #3 boundaries are as follows:**

The POB. 15 ½ miles West of the NE Corner of Kiowa County on the ½ Mile line of (Section 4 Township 27 Range 18) then South on the ½ mile line thru (Sections 4,9,16,21,28,33 Township 27 Range 18) and (Sections 4,9 Township 28 Range 18) (30<sup>th</sup> Ave) to the city limits of Greensburg Then West on I Street to Bay Street then South on Bay Street to Scott Street then West on Scott Street to (29<sup>th</sup> Ave) Then South on 29<sup>th</sup> Ave 1½ Mile to the (SE Corner of Section 29 Township 28 Range 18) then West 1 mile to the (SW Corner of Section 29 Township 28 Range 18) (183 Hwy) then South 13 miles to the (SW Corner of Section 32 Township 30 Range 18) Kiowa County line then West 13 miles on (Y St) to the (SW Corner of Section 31 Township 30 Range 20) then North on the section line 24 miles (1<sup>st</sup> Ave) to the (NW corner of section 6 Township 27 Range 20) then East 14½ miles to the POB.
