## Kiowa County Commissioners Meeting August 31, 2022

David White, Bert Lowery, John Bertram, Kristi Cooper, Chay Howard, Jay Schmidt, Kendal Lothman, Julie Lyon, Kerri Ulrich and Stacey Weaver attended the meeting.

Consent agenda included: Agenda, Payroll report, Accounts Payable reports, and Commissioner minutes of 8/15/22.

After prayer given by Stacey Weaver and the pledge of allegiance recited, David White opened the meeting at 9:00. Bert moved to approve the consent agenda as presented John seconded, motion passed unanimously.

Karen Butler came to present a separation payroll change and reported her last day would be September 30<sup>th</sup>. After review of the payroll change Bert moved to approve and John seconded, motion passed unanimously.

Kristi Cooper presented tax corrections for approval. After review of the corrections, John moved to approve them as presented and Bert seconded, motion passed unanimously. Next, she presented minutes of August 15th and AP reports and PR reports for signatures. Also reported their next meeting will be September 6<sup>th</sup> due to the courthouse would be closed for Labor Day.

John moved to approve for Chay to move forward filing for a petition for a quite title with the 6x6 AM General that was sold with no title and to get 3 titles on the existing trucks that are in service at the fire departments and Bert seconded, motion passed unanimously. Lastly, he gave a few updates on the tax sale.

Clerk recorded the roll call vote. Next Dave moved to adopt the 2023 County budget as presented and to set the county levy at 74.983 mills and John seconded, motion passed 3 yes and 0 no.
