## A RESOLUTION COMMENCING PROCEEDINGS TO DECLARE CERTAIN ROADS OR PARTS OF ROADS IN KIOWA COUNTY, KANSAS, MINIMUM MAINTENANCE ROADS.

At the conclusion of the hearing the Board of County Commissioners of Kiowa County, Kansas, shall determine what roads or parts of roads described in this resolution are to be declared by it minimum maintenance roads
