The Kiowa County Commissioners met in regular session Monday, September 16, 2024 at 9:00 am in the Commissioners room located in the basement of the Courthouse. The following members were present: Chairman John Bertram, Vice-Chairman David White, Commissioner Bert Lowery, County Counselor Chay Howard and County Clerk Kristi Cooper.

After the pledge of allegiance was recited, John Bertram opened the meeting at 9:00 am. Bert moved to approve the consent agenda with additions as presented and David seconded, motion carried 3-0.
